There are related expenditures for the box office. Three newsletters were provided electronically to the public to promote awareness of the operas and the company.

4b (Code:) (Expenses \$ 105,416. including grants of \$) (Revenue \$ 36,841.) Education programs include: touring productions for elementary, middle and high schools; final dress rehearsals open to students. Over 15,000 students were reached by these programs.

4c (Code:) (Expenses \$ 275,391. including grants of \$) (Revenue \$ 44,545.) Kentucky Opera sponsors various activities in order to promote opera awareness and increase support. These activities include Opera Previews, outreach/community engagement performances by Kentucky Opera's Studio Artists, and Lunch & Listen.
